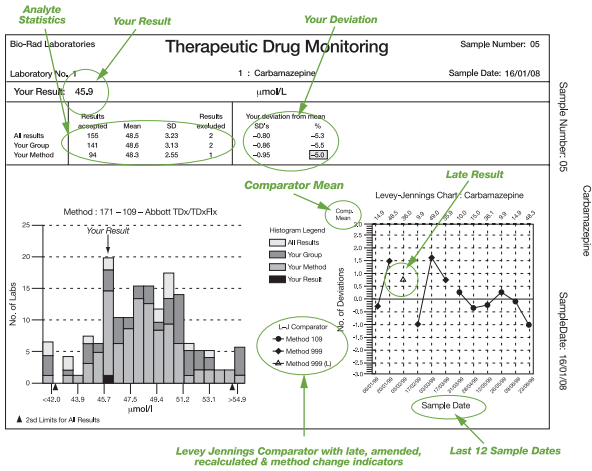

Participants receive 12 bi-weekly reports and one end-of-cycle report over each program cycle. All reports are available within three days of the statistical analysis.

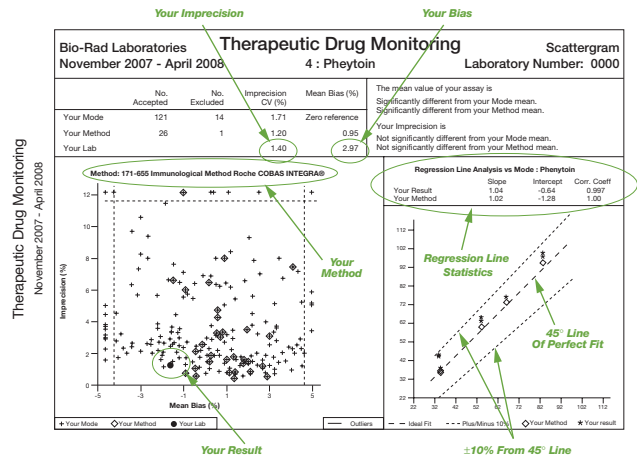
Bi-Weekly Report (Example)
